DECLARATION

Statutory Declaration under Section 4(1)(b) of Right to Information (RTI) Act, 2005

The **Right to Information Act, 2005** provides for right to information for citizens to secure access to information under the control of public authorities in order to promote transparency and accountability in the working of every public authority. According to UGC guidelines all recognised Universities and Colleges shall come within the purview of a Public Authority under this Act. Hence, **Raath Mahavidyalaya, Paithani**, Pauri Garhwal, Uttarakhand is come under this category and section 4(1)(b) of RTI Act 2005 is applicable to the college.

Raath Mahavidyalaya, Paithani is recognised by UGC under section 2(f) and by Government of Uttarakhand. It is affiliated to HNBGU Srinagar Garhwal, Uttarakhand. Our college is a co-education college and running under a registered society **Raath Shiksha Vikas Samiti**, which is registered under Society Act by Govt. of Uttarakhand. The College has a Governing Body which runs as per rules and regulations made by the Govt. of Uttarakhand from time to time. It runs as per the rules and regulations made by statutory bodies like State Government of Uttarakhand, UGC, NCTE and Affiliating University from time to time. The College has established the statutory bodies and various committees and cells which come under section 4(1) (b) of RTI Act 2005. The applications under the RTI Act along with a postal order/demand draft for Rs.10/- obtained in favour of Principal, Raath Mahavidyalaya, Paithani may be sent to the Public Information Officer (PIO) or handed over in his office. All the information about the college under section 4(1)(b) of RTI Act 2005 is available for the public and it can be obtained by any citizen of India.
