

## **Policy Document/Guidelines of Post-Matric Scholarship**

**(Note: This is Translated version of Policy Document/Guidelines of Post-Matric Scholarship Scheme of State Government of Uttarakhand. Original guideline enclosed herewith is published in Hindi language at National Scholarship Portal: <https://scholarships.gov.in>)**

**For the students of Scheduled Caste, Scheduled Tribe and Other Backward Caste, studying under the online post-matric scholarship scheme, scholarship is provided as per the following standards-**

### **Eligibility for Scholarship Application:**

- The student who is a Native/Permanent Resident of Uttarakhand State should be studying as a regular student in a recognized School/ University/ Technical/ Medical/ Management Institute running in the state or outside the state.
- The student must have passed the previous year's examination.
- The student should not be studying in more than one institution in the same academic year.
- Family annual income from all sources of parents and guardians of Scheduled Caste/Scheduled Tribe students is Rs. 2,50,000/- (Rupees two lakh fifty thousand only), Family annual income from all sources of parents and guardians of OBC students is Rs 1,50,000/- (Rupees one lakh fifty thousand only)
- Students applying for scholarship should select the correct institute in which they are studying while filling the online application form.
- The information filled in the application form submitted by the students studying in the universities/institutions located in the state or outside the state, if it is as per the prescribed standards then the concerned institution will send the student's online application form for scholarship from its level to the District Social Welfare Department of the concerned district of which the student is a native/permanent resident.
- In case of being eligible for scholarship, there is a provision by the concerned District Social Welfare Officer to transfer the scholarship and fee amount online to the CBS account of a nationalized bank operated in the name of the concerned student.
- This scholarship is provided under the rules prescribed by the Government of India/State Government.
- Under the Scheduled Caste/Tribe Post-Matric Scholarship Scheme, scholarship is first paid to the students studying in government and aided schools. By giving priority, to non-government/professional minority educational institutions. students of non-government schools and students studying in professional educational institutions whose admission has been done under the management quota, on the basis of availability of funds, starting from the poorest student in ascending order, payment of scholarship is ensured. Scholarship/fee reimbursement is given first to the eligible students studying in the state of Uttarakhand. Thereafter, depending on the availability of funds, payment of scholarship is ensured to the students of Uttarakhand studying in other states.
- Other Backward Classes Post-Matric Scholarship is a Fund Limited Scheme. Therefore, under this scheme, only such students studying in courses of Uttarakhand Technical Education Council and ETCN/ICM/ETCIA etc. will be benefited, whose admission has been done through counselling, and not those students who have been admitted through management quota.

Necessary self-attested documents for scholarship application under the Post-Matric Scheduled Caste/ Tribe, Other Backward Caste and Disabled Scholarship Scheme-

- Income Certificate of parents/guardian (not older than 1 year)
  - Caste Certificate
  - Domicile/Permanent Residence Certificate
  - Mark Sheet of High School
  - Mark Sheet/Certificate of previous passed class
  - Bonafide Certificate from the Current Educational Institution
  - Bank Passbook of CBS Account
  - Counseling Certificate (For Other Backward Caste Scholarship)
  - Disability Certificate (for Disabled Scholarship)
- To students of SC/ST, studying in post-matric classes, scholarship is provided as per the following rates and standards: -
